Some members found it difficult to discern who falls within the scope of the Register. We struggle to understand how to calculate the salary proportion of staff with accreditation rights that should be declared. This decision should be left to the registrant who knows how much time their employees spend on activities that fall under the Register. The same goes for employees with no accreditation, whose occupation isn't related to EU Affairs but who have occasional meetings with EU officials.

Interest representation is valued as a constructive and meaningful contribution to EU decision making. The Joint Transparency Register can be an instrument to provide transparency and to ensure interest representation is done with integrity. We sincerely hope that the Joint Register will form the basis of a credible yet workable system for all EU actors. With this in mind we hope that the Commission will re-evaluate its decision, as stated in the updated guidelines, to force all associations to report 100% of the salary of its employees who have requested access rights. AmCham EU feels that, even though an employee has asked for access rights this does not mean that he spends 100% of its time in activities that fall within the scope of the register.
