Liam Benham was appointed President of EU, NATO and Government Affairs Europe at Boeing International in December 2022.

Liam is responsible for expanding Boeing's presence and pursuing new growth opportunities as the senior Boeing representative in France and Southern Europe. As head of the Boeing Brussels office, he also represents the company's interests with key European Union institutions, European regulators and NATO. Working closely with Boeing teams across Europe, he leads the company's advocacy for informed decision-making on key EU policies that strengthen transatlantic ties, advance Europe's economy, promote sustainable growth, contribute to a safe, innovative and competitive aviation system, and connect EU citizens and businesses.

Liam brings over 25 years of senior government relations experience stemming from his work for global enterprises with a US heritage.

Prior to Boeing he served as Vice-President, Government and Regulatory Affairs at IBM Europe for over a decade, focusing on a broad spectrum of topics of interest - from AI, cybersecurity and privacy to trade, taxation and the EU Digital Single Market. Liam also held senior government relations positions for 15 years at the Ford Motor Company, where he focused on key regions of interest, including Europe, Asia Pacific and Africa.

Liam holds a Degree in Politics from the University of Bristol. He is the current Chair of the Board of the American Chamber of Commerce to the European Union (AmCham EU), and has previously served as Board Member of the organisation in the EU and Thailand. Liam has also previously served as Vice-Chair of the BusinessEurope Digital Economy Taskforce, and Board Member of DIGITALEUROPE.

Philippe Ducom has served as the President of ExxonMobil Europe since August 1, 2018. He is based in Machelen, Belgium.

Philippe joined ExxonMobil in 1987 as an engineer and has since held various positions in manufacturing, business analysis, planning, sales and marketing in Europe and the United States. He is a strong believer in the potential of technology and innovation to address the dual challenge: meeting the world's growing energy demand while addressing the risks of climate change.

Philippe was born in Rueil-Malmaison in France. He graduated from Ecole Polytechnique and has a degree in chemical engineering from Ecole des Mines de Paris.



**Deri Watkins**Vice-Chair, Executive Council, AmCham EU

Deri Watkins stepped into his position as the Regional President of Mars Petcare Europe in June 2019. However, his work at Mars Petcare Europe far precedes this. Deri has been working at Mars since April 2001 and has held countless notable roles such as Chief Customs Officer, General Manager and eventually Regional President.

Deri has been a key architect for the rapid acceleration of Mars Petcare's ecommerce capabilities globally. He has a deep knowledge of Capability Building, Strategic Revenue Management, Category Leadership, Store Execution, Strategy and Strategy Deployment.

In addition to his work with Mars Petcare Europe, Deri has also engaged in volunteer work. Not only has he served as trustee of Battersea Dogs & Cats Home, but he has also been President of the Sweet Charity (Now Grocery Aid) for one year, and trustee and active committee member for two years.

Joseph Quinlan Senior Fellow Transatlantic Leadership Network

Joseph Quinlan is a leading expert on the transatlantic economy and a well-known economist/strategist on Wall Street. He specialises in global capital flows, foreign direct investment, international trade and multinational strategies.

Joseph lectures on finance and global economics at Fordham University. In 1998, he was nominated as an Eisenhower Fellow. Presently, he is a Senior Fellow at the Transatlantic Leadership Network, and has served as a Fellow at the German Marshall Fund. He was appointed a Bosch Fellow at the Transatlantic Academy in 2011. In 2006, the American Chamber of Commerce to the European Union (AmCham EU) awarded Joseph the 2006 Transatlantic Business Award for his research on US-Europe economic ties. In 2007, he was a recipient of the European-American Business Council Leadership award for his research on the transatlantic partnership and global economy. Joseph regularly debriefs policy makers and legislators on Capitol Hill on global trade and economic issues. He has testified before the European Parliament. He has served as a consultant to the US Department of State. He is also a board member of Fordham University's Graduate School of Arts and Science and serves on Fordham University's President Council.

He is the author, co-author, or contributor to over twenty books. He has published more than 125 articles on economics, trade and finance that have appeared in such venues as Foreign Affairs, the Financial Times, The Wall Street Journal and Barron's. He regularly appears on CNBC, as well as Bloomberg television, PBS and other media venues.



Susan Danger CEO AmCham EU

Susan Danger is the CEO of the American Chamber of Commerce to the EU (AmCham EU), which speaks for American companies committed to Europe on trade, investment and competitiveness issues. She has full strategic and operational responsibility for the association and represents it externally. AmCham EU is a membership organisation supporting over 155 US corporate companies, international businesses, and law and consultancy firms in the area of public affairs.

Susan has dedicated her entire career to building a strong and united Europe and with that, developing the EU's Single Market, as well as maintaining and strengthening the transatlantic relationship. She joined AmCham EU in 1995 as Communications Manager, becoming Communications & Operations Manager in 2000. Since 2002 she has been leading the organisation as Managing Director and since 2016 as CEO. In 2003 she lead the founding of AmCham EU as an independent organisation and its separation from AmCham Belgium. AmCham EU was voted Best EU Trade Association of the year in 2021 by BestinBrussels.eu. In 2017 AmCham EU was awarded for the fourth time the Trade Association/Professional Body of the Year Award, having previously won the award in 2009, 2012 and 2014.

Susan was named by POLITICO as one of the top 20 women influencers in Brussels in 2016 and 2020.

Susan was elected Chair of AmChams in Europe (ACE) for four years during the period 2020-2023. AmChams in Europe (ACE) serves as the umbrella organisation for 49 American Chambers of Commerce (AmChams) in 47 countries throughout Europe and Eurasia. She also served as Vice-Chair for six years (2009 - 2014) and was a Member of its Executive Committee (2005-2008).

Susan was appointed a member of the Governing Board of the European Policy Centre in March 2021.

A graduate of the University of Bath, UK, with a BA in European Studies, French and German, Susan's career developed in London in marketing and communications within the tour operation industry, where prior to coming to Brussels she worked for Thomson Tour Operations.

A dual UK and Belgian citizen fluent in English, German and French and conversant in Dutch and Spanish, Susan Danger lives in Brussels with her family. She has three children.

Doru Frantescu is the CEO and Founder of EU Matrix, an EU focused research platform which combines expert insight and digital technology to provide factual and objective information on how the EU political machinery works. Doru has over 15 years of experience in advising on EU policy-making, having previously founded and headed VoteWatch Europe. He has been nominated by POLITICO Europe as one of the top 40 most influential personalities in EU affairs. His work has been quoted as an example of best practices by the EU and national institutions and he's been interviewed by the media around the world (including Financial Times, Bloomberg, Euronews, CNN, France24, BBC, etc). He is also co-author of 'How to Work with European Institutions' (John Harper Publishing).

In 2008 in Romania, Doru co-founded his first organisation, the Euro-Quorum Institute for Participatory Democracy which has trained thousands of young people in the democratic processes.

Since 2018 he has also been a member of the European Alliance for Artificial Intelligence. Having lived in several parts of Europe, he works to be a bridge-builder between cultures and professional sectors.

Quang-Minh Lepescheux is Director of EU Government Affairs for Microsoft, based in Brussels, and member of the Strategic Relations team. Prior to joining the EU team, Quang-Minh was Government Affairs Manager for Microsoft France, in Paris. In that capacity, he served as Chair & Spokesperson of the Business Software Alliance (BSA) French Committee. Before joining Microsoft in 2011, Quang-Minh was Legal & Government Affairs Manager at Union des Fabricants (Unifab), the French Intellectual Property trade association, and was previously Legal Counsel at Louis Vuitton. Quang-Minh holds a bachelor's degree in business law from the University of Paris and a master's degree in IT and IP Law from the University of Strasbourg. He has lectured in various master's programs, notably at Sciences Po Paris and the University of Montpellier.

Jaume Duch Guillot is the Director-General for Communication of the European Parliament and its Spokesperson. He graduated in Law from the University of Barcelona (1980-1985), where he later also served as a Professor of International Public Law. In 1990 he became a European Parliament official and since then has always worked in communication-related positions, such as Spokesperson for the then President of the European Parliament, José María Gil-Robles, Head of the Press Room or Media Director, a position to which he was appointed in 2006. In February 2017 he was appointed as Director-General of Communication, a role which he combines with being the Spokesman of the institution. The work of the Directorate involves raising awareness of the European Parliament, its powers, its decisions and activities among media, stakeholders and the general public.

Jaume is the author of various publications, articles and communications on issues related to the European Union, the role of the European Parliament and communication policies.

At the intersection of policy and communications, Thibaut L'Ortye leads advocacy campaigns and provides strategic advice on a range of policy issues impacting industries across sectors. Guillaume Dubois stepped into his role as the Chief Executive Officer of Euronews in June 2022.

Before joining Euronews, Guillaume was the Director of Broadcasting for the French 24-hour news channel LCI (TF1 group). Guillaume also has experience working as a presenter for B Smart. From June 2020 until July 2021 he presented the 'Late & Smart' segment which aims to understand the current news, in France and around the world.

In 2019, Guillaume co-founded and became CEO of Betty Media. Guillaume has also held various positions within the Altice Media group: Managing Editor and

then Managing Director from 2005 to 2016 of the all-news channel BFMTV; Managing Director of BFM Business, from 2003 to 2016; Deputy Managing Director and then Chairman and CEO of L'Express Group, 2016-2018. Guillaume also acted as Editor-in-Chief for EMAP and then for Le Nouvel Economiste between the years of 1996 and 2002. Guillaume is the author of 'Priorité au direct' (Plon, 2015) and a graduate of Sciences Po where he studied Finance.






# European Parliament (venue of the Transatlantic Reception)
