ECONOMIC IMPACT OF THE FTA: A WIN-WIN FOR ALL



16th biggest EU trade in goods partner

The free trade agreement (FTA) between the EU and Vietnam, concluded in 2015, is the most ambitious trade deal ever negotiated between the EU and a developing country. The FTA will eliminate over 99% of all tariffs, and partly remove the rest through limited zero-duty quotas, known as Tariff Rate Quotas (TRQs). Tariffs on EU exports to Vietnam will be gradually removed over a 10-year period. EU duties on imports from Vietnam will be eliminated progressively over a 7-year period.

NOT ONLY GOODS...

Vietnamese exports to the EU:

- Are expected to rise by 29% by 2035*
- Will see 71% of tariffs disappear on entry into force

EU exports to Vietnam:

- Are expected to rise by 18% by 2035
- Will see 65% of tariffs disappear on entry into force

...BUT ALSO SERVICES AND PUBLIC PROCUREMENT

New business opportunities will be offered in Vietnam in many services sectors like business, computer, telecommunication, environment and insurance. The FTA also provides new possibilities for European businesses to tender to public procurement projects, providing public entities in works, goods and services in Vietnam.

FOSTER SUSTAINABLE DEVELOPMENT IN VIETNAM THROUGH TRADE



Vietnam's development over the past 30 years has been remarkable. Economic and political reforms under **Đổi Mới**, launched in 1986, have spurred rapid economic growth, transforming what was then one of the world's poorest nations into a lower middle-income country.

The FTA includes robust, **comprehensive and binding provisions** which will help address some of the challenges Vietnam is still facing concerning **labour rights and working conditions**.

FTA provisions on human rights and sustainable development

- Institutional and legal link to the **EU-Vietnam Partnership and Cooperation Agreement**, allowing appropriate action in the case of breaches of human rights
- **Trade and Sustainable Development Chapter** including binding obligations for both the EU and Vietnam with regard to a core set of multilateral standards and agreements on labour and the environment
- **Creation of Domestic Advisory Groups** as a mechanism for each Party to request and receive inputs from representatives of its civil society
